4-H County teams, School FFA Chapters, Individual Youth are all invited to attend.

Attempts will be made to select only horses that are serviceably sound, and they will be judged "as they are" in performance classes and "sound" in conformation classes. At the beginning of each performance class, if the official judge(s) determines that a horse is not serviceably sound (lame and/or blind in one or both eyes), that horse will be identified to the contestants and should be placed at the bottom of the class.

The four horses in each halter class will be of similar type, the same sex, and approximate age.

Breed classes will be judged by the standards set forth in the rules of that breed. Tack and attire are not to be considered in placings.

Participants will judge four classes of which at least one will be conformation classes. Any youth may give oral reasons. Oral reasons classes will be announced when the classes enter the ring. Participants will only give 1 set of oral reasons from which they will receive immediate feedback from the taker.
